

HELPING HANDS CHALLENGE - RULES OF ENGAGEMENT

ARTICLE 1 – THE CONCEPT

The Helping Hands Challenge is a race connected organized by Helping Hands Association in order to:

- a- propose a sportive event in friendly spirit
- b- collect funds for Helping Hands Association

This race is a sportive challenge, but also an event adapted to all.

The participant can run, walk, bike or swim.

The objective for the participants is to do as many kilometers as possible despite the type of activity in the given period.

For each kilometer done by an Amadeus employee, Amadeus France (Nice, Paris, Strasbourg) will give 1 euro to Helping Hands, for a maximum 1,000 euros. The participants external to Amadeus can also join the challenge – their participation will count in the global counter, but no subsidy will be given.

ARTICLE 2 – USAGE

The participant is committed to do a number of kilometers during the duration of the challenge (14 days).

The participant is committed to declare the distances done by publishing the gpx file (connected application to download for free on smart phone or connected watch). If not possible, the participant will estimate the distance done closest to the reality.

The participant can take his/her photo during the challenge to demonstrate the participation to the challenge & promote his effort.

ARTICLE 3 – LOCATION AND DATES

You can participate to the challenge from anywhere. There is no defined track – just need to do the distance selected with a connected device. The challenge will take place from **Monday 12th to Sunday 25th September 2022.**

ARTICLE 4 – ENROLMENT / PRICE

The challenge is opened to all: adults and kids (with parents' authorization and presence of an adult). You can subscribe to the race via Helping Hands site.

Price is **5 euros per participant**. If you join with your team, it will be an individual contribution of 5 euros. You can give a higher contribution if you wish. By subscribing to the Helping Hands Challenge, you accept to comply with the present rules.

All benefits will be given to Helping Hands Association.

ARTICLE 5 – ENGAGEMENT

All engagement is personal and final and no reimbursement can be requested. No registration transfer can be authorized for any cause.

ARTICLE 6 – RACE DURATION

The Sportive Challenge will start on **Monday 12th September 2022 from 6H00 until Sunday 25th September 2022 - 23h59** to upload your gpx file.

ARTICLE 7– IMAGE RIGHTS

By enrolling in the challenge, the participant authorizes Helping Hands Association to use or reproduce the image uploaded during the challenge for the promotion of Helping Hands events on social networks.

ARTICLE 8 – INSURANCE

You are participated for this connected race under your own responsibility and at your own risks.

You know that the activity needs a physical preparation adapted to the race and you are certifying to be in good shape, have done a medical check up less than 1 year ago and have the necessary capability to participate. You are confirming that you have your own personal individual insurance to cover possible physical damages. You are releasing the responsibility of Helping Hands Association, all members and organizers of any responsibility for any claim linked to personal injuries, death or material damages resulting from your participation to the Sportive Challenge.

ARTICLE 9 – PRIZES

The challenge is based on solidarity principle. Amadeus contributes to 1euro per kilometer done, limited to 1,000 euros maximum.

ARTICLE 10 – DATA PROTECTION

Helping Hands Associated is committed to respect and protect your private data.

The categories of personal data you are being asked to consent to Helping Hands are your name, address, email address, gpx file of your race and a picture. We will use the gpx to check that you completed the race and we will choose among the pictures the best one for each category.

Helping Hands will not share your personal data with any third party. However, the name of the winners and the best pictures will be published on the social media of Helping Hands.

Your personal data will be stored in accordance with the GDPR and will be erased as soon as the winners of the competition will be announced. Under the GDPR, you have the right to request access to, rectify, erase and restrict the processing of your personal data. You also have the right to revoke this consent to use your personal data. However, we remind you that doing so we will not be able to process your data for the selection of the winner. To perform any operation on your personal data, you can contact direct Helping Hands.
